To Whom It May Concern:

On October 23, 2015, the Alabama Community College System (ACCS) issued a Request for Bid (RFB) for the Alabama Community College System and Alabama Higher Education Joint Purchasing Agreement for computer equipment with peripherals, software, networking equipment, maintenance, professional support services, and other technology-related equipment.

I want to thank you for responding to this request by submitting a bid. By this memorandum, I am announcing the vendors to whom the bid will be awarded. An evaluation committee comprised of two-year and four-year institution technology experts reviewed all responses to the RFB and selected forty-five vendors, based on the criteria specified in the RFB, who will become part of the joint purchasing agreement for a period of one year. The scope of vendors chosen should meet the diverse needs of the institutions of the ACCS and other higher education entities. The vendors recommended to me by the evaluation committee and to whom I am awarding the bid, effective March 1, 2016, are as follows:



Based on this recommendation, I am hereby notifying the successful vendors that this contract shall be automatically renewed on March 1, 2017, for a period of one year, unless 60 days' notice of termination is given by either party.
